that was found at home by Zacharias.
Is there anything you would like to say about that?
Yes.
It was something...
That the knife was in...
I don't know if it was Daniel's or Tobias' box.

Someone saw it.
Someone of the two.
That there was a knife in there.
And it looks about like that.
And it can be that.
And this box that you are talking about,
it is preserved.
Yes, it is in the toilet.
It is often used to do that.
Yes, there has also been a result from NFC.
That there is a blood sample on the skull of a lion on the floor in the toilet.
And it is then a DNA that comes from Zacharias.
What?
Oh, I'm sorry.
I haven't done anything, so I'm sorry.
I can't be sure how it has come out.
The injuries on Zacharias.
He had 20 greater injuries in about...
And they were caused by sharp wounds.
There are even more wounds on Zacharias body from external wounds.
I thought I would show you some pictures.
Excuse me.
Apart from these injuries, there are also external wounds.
Also caused by an egg vest.
Yes.
Do you have anything else that you would like to tell?
No.
Just the scaring that there is in my living room.
It scares me.
Not me, but it scares me what happens to me.
I'm afraid of myself.
Who are you afraid of?
Or what are you not afraid of?
What is the question?
It scares me.
On a Sunday in February 2023,
Zacharias Nordfors, who is usually home to his mother, eats lunch.
And late at night, he gets home.
The last activity on Zacharias' phone is close to midnight.
And at 00.05, the alarm goes off.
To open next time, 00.28,
when Zacharias calls SOS Alarm
because he has been stabbed in his stomach.
The police quickly report their mistakes

to 42-year-old Anni and 48-year-old Morten.
And it is reported that they are going to have a fight with Zacharias.
At the same time, as the two are suspected,
Anni's son, Daniel, and her sister, Frans and Rasmus,
are heard as witnesses.
The Cussidens have died during the weekend
and they are going to sleep at home with Anni on Saturday night.
But the witnesses' goals are different.
And how far Rasmus has slept on Saturday night
and how far Rasmus has slept on Saturday night
or not, they share their opinions.
When Anni's DNA is found on a knife at home
at Zacharias' house, the blood is noted in the evidence
on Saturday night, and the details in the Cussidens'
stories about the Sunday do not go together.
That leads to new mistakes.
And at the end of April, 23,
Daniel and Rasmus are also arrested,
suspected of murdering Zacharias.
Listen to Daniel Ström, April, 23.
Then we have to listen to Daniel Ström.

I usually go to my cousins,
Frans and Rasmus.
Sometimes,
but very rarely,
I usually go to my friends.
And then I can only drink
and party.
And then there is also
the job search,
the future plans.
That's right.
And you have mentioned that Rasmus and Frans,
they are your cousins,
and that you interact with them.
Can you describe your relationship
to them?
My relationship?
Yes.
Well, we usually play together,
so...
We often meet and greet each other
a few times a week,
so...
I see them often.
Are you any closer to each other?
Well...
A little closer to Frans,
than to Rasmus.
But you are friends with both of them?
Yes.
Earlier,
we also talked about this
sexual intercourse
that Sakaria spent

about 15 years ago.
Is there anything more
that you would like to tell or have come up with?
No.
And your feelings
for Sakaria after this?
In recent times,
how have they expressed themselves,
and how have you felt?
They haven't changed anything.
I said earlier that it was...
It was...
It's so boring,
but I didn't feel anything like it.
So...
No.
There's nothing I can do about it now.
You have told me earlier
that you,
Anni and Frans,
were in the hospital
on Sunday night.
And you watched the movie,
listened to the music.
And that you were late
after 24,
but that you were unsure of the exact time.
Yes.
I don't really remember when we were late.
It was...
It looked very dim.
And Frans,
that night.
Did you sleep anywhere?
In the sofa.
But it could also have been a bed.
But...
It was fun to sleep in the sofa.
When Rasmus and Frans slept.
What did you say?
Rasmus and Frans?
Rasmus also slept there?
Yes.
That night?

Yes.

And where did he sleep?

In the sofa as well.

When we have counted the names
earlier,

which were on the left,

Rasmus also slept there.

But you mean that he was also there?

Yes.

Rasmus and Frans.

I hope I forgot to say Rasmus
as well, but Rasmus was there.

And Anni,

where did she spend the night?

She was in the living room,
the kitchen
and her room.

Is there anyone who leaves
Saturday night
on Sunday?

On Monday night?

No.

I think

everyone was standing there
and sleeping.

Rasmus and Frans
were standing there
and sleeping.

Rasmus,
do you know anything
about that?

Do you have anything
to do with Zacharia?

No, absolutely not.

I don't think so.

Anni and Morten,
they have been back for a while.

What is their
influence on this mood?

Nothing.

They haven't done anything.

And how do you know that?

I was with my mother
and I thought she would do it.

That's why.
And did you know
that Rasmus
lives on the other side
of the garden
and thinks
from the red house
on that side?
Did you know that
before this weekend?
That he lived on the other side?
Yes, on the garden
or on that side?
Yes, I knew that.
I will show you
a picture
of how you did this.
No.
This knife was taken
from the crime scene
on Zacharia's apartment.
Okay.
On this knife
there is DNA from Anni.
Okay.
And Zacharia's.
Yes, I don't know anything.
Do you have any explanation
why this knife is on the ground
and
does it have DNA on it?
No, nothing.
It also
has been done
on the ground
where Zacharia's blood
has been found
on the floor of your apartment.
Okay.
Can you explain?
I had no idea.
What do you think
when you hear this?
Well,

it sounded horrible.
Of course,
then you mean
that my mother was involved in this.
You hear
what we say.
No, I have no idea.
I had no idea.
I don't know.
How can Zacharia's blood
be found in your apartment?
I don't know.
Seriously.
How are your thoughts?
Well,
I'm
so shocked.
No,
I'm
shocked
and upset, of course.
Do you know anything about this?
Nothing.
Zacharia's blood
has been found on the floor of your apartment.
I don't know.
During the month
that you've also told
your mother about it.
Yes.
Tell us about it.
Yes.
There's not much to tell about it.
I
have told you about it before.
They went on their way.
I was at home.
Why did they go on their way?
To look at the house where they lived before.
Because they had talked about it.
That's what I know.
What have you never expressed
to Zacharia?
How did you feel about her?

That she didn't like it.
That's what I remember.
And when did you express
that to her?
Well,
when she expressed it.
You mean
that after he left?
Yes, before or after.
Well,
it has been before
and after, of course.
And what did she say?
That he is a pedophile
and a violent man.
And in what sense
can you explain it more?
When she tells
when she talks about Zacharia.
What do you mean by that?
Expression,
reading.
You can be in different ways
when you express things.
Yes, both
expression and reading
so.
Can she have done something to Zacharia?
From how she expressed herself
about her?
I don't want to answer that.
What is the reason for you not
to answer that?
You don't want to answer that.
You are mistaken for
a mother.
Tell me.
What should I tell you?
You say you understand it.
Well,
I...
I have contact with my mother
and my mother
and then

what happened to me before
when I was released
is why I didn't say I missed it.
And Zacharia's DNA?
Or blood in your stomach?
Yes, what should I say about that?
I don't know anything about it.
Anni says that
the knife that we show up
as you have seen in the picture
is in your stomach.
Okay, I don't know anything about it.
You don't agree?
Or do you just know about it?
I don't know.
But I really don't think that
mother or mother has done it.
What have they done?
I don't know.
Think about what they
prove to exist.
Yes, I...
I don't think they have done it.
Why don't you believe that?
Because I saw my mother.
And I know that my mother is there for it.
And I don't think that mother would do it either.
Is there anything now
that you want to tell us?
To add to this situation?
Yes, that
I haven't done it.
And not mother and not mother.
Who have you done it to?
I don't know.
I... No, I don't have anything to add to it.
I don't have anything to add to it.
Yes, then we will stop.

I contacted you because I wanted to admit myself as a guilty victim of saccharine.

I felt for the first time, for the first time,

the first person I felt was my father.

And they were completely shocked and they did not understand that it was me.

And I called, I wanted to myself that my father would call you.

I wanted to then...

I felt like a guilty mother.

I did not want anyone else to sit idle when I know the situation.

Which one was more the one who was murdered?

The one who murdered me.

Yes, that is what I am saying.

This conversation is told.

Yes.

I was with Daniel late at night, I think.

It was late at night, that was it.

We decided to just suddenly,

all of a sudden, without...

Without any planning from...

We did not have any planning on ourselves,

but it was...

It was something in...

Psychic.

What it was.

It affected us both mentally.

And then we decided to do it.

We went to...
From Levgränd to Jortronstegen 5B.
Saccharine's apartment and knocked on.
Saccharine opened the door.
Daniel gave...
Daniel gave him a punch with his hand first,
and then after that we both hit him.
And I say...
I say now...
I had never...
been on any innocent person in the whole...
Absolutely not.
In the whole of my life.
It really needed...
To get to that point.
When you go so far, believe me,
it made it...
It took me a lot, because I realized that...
This is not me.
But he had affected so much...
My psyche as well.
I felt so bad about it.
About everything that happened.
Daniel and Rasmus, and not only them,
a lot of innocent people who were sacrificed for Saccharine.
Both victims, and pedophilia, all of this.
I just wanted to get an end to it, so then...
Yes, it was Daniel.
The way Liljeboom, Rasmus Vestman and Anistrum,
that none of these three have anything to do with this.
They don't even know who it is.
No one knows anything.
Daniel and I are behind this.
It's us...
Who are the victims, and it's no one like that.
How does it feel now, when you have...
been told?
It feels good to be told about...
Something I bear as a secret to all of you.
But I'm stuck in my decision, me and Daniel.
Me and Daniel's dream.
And I have never gotten anything,
any crime in my life.
This is the only crime I...

I...

I...

I have endured it, and I stand for it now.

And I'm not a bad person, actually.

I'm not, and I hope I don't stand as a psychopath or anything,

but I...

I tried to make the right decision.

You're telling me that you were together with Daniel?

Yes.

What happened then?

In his situation, and he died.

Or not, he died because we...

hugged him, and then we ran away.

I don't remember where.

What place is it?

I don't know, I don't remember this place.

But the clothes are up there.

And the knives I have...

for me were cast.

I think it was like that.

Before, you told us that you went to Jortunstegen.

Yes.

You and...

Daniel, late.

What the hell did you do before you went to Jortunstegen?

Løvgren.

That's right.

But...

I mean...

everyone else had gone to Laktse, I don't think...

I think...

When I say this...

I don't even think...

I don't even remember who Rasmus was at Løvgren.

I think he was home.

He had...

He had already gone home.

Tell us about what happened last night before you went to Jortunstegen.

What are you up to?

What are you doing?

Tell us a little bit.

I'm with Daniel.

We...

I think we...

I think we still...
I don't know if we're still in the living room.
It's just that we're watching a movie.
And the others have gone to Laktse or something.
But we're actually watching a movie.
And then...
We decide to...
end this...
psychical...
unhealthy...
Because it feels like it's...
gone too far for both of us.
Both of us, Daniel and I...
We both had to...
be so bad...
about this.
And I couldn't...
let it just go, like...
Tell us a little bit more about Løvgren.
What are you up to tonight?
I think it's me...
Daniel, Anni...
And...
I don't remember if Rasmus was there...
Honestly.
I forgot about him.
I think he might have gone home...
with...
Yeah, with the biggest accident.
Before this happened to his apartment.
Yeah.
All the others...
had gone to Laktse...
at that point in time.
When me and Daniel went out and...
So no one else knew.
It was just me and Daniel.
Tell us about the reason you went out.
We had decided to...
give him...
injuries.
But we didn't...
maybe...
I don't know if I had the courage to think.

I didn't think it was like...
he's going to die or something...
but to give him injuries...
so that he could...
be able to...
get back what he's done...
other unskilled things.
That's how I see it.
Tell us how it went when you decided.
Yeah, we took...
Thomas' knives.
Black clothes.
We went out from...
Løvgren.
We went out and ended up in Jutlandstyggen.
And then...
we hit him down.
I didn't know that he died...
the day after.
I noticed that he died...
because then it was in the newspaper or something.
That was it.
And...
Zacharias.
Then he gets the first knife hit.
Yeah, he...
says that he gives himself...
but in my opinion...
he can't be allowed to...
be allowed to do what he's done.
But he says that he gives himself.
Yeah, but it doesn't change.
I...
why do I or Daniel listen to that?
Because...
we know how he was...
what he was like...
what he's been through.
And then...
we leave the place after that.
And then he stays in his apartment on the floor.
Your feeling when you left Jutlandstyggen?
Yeah, I...
I...

I didn't feel good about what I did.
There's nothing I...
I don't think it's fun at all.
But it's something I feel...
that it needs to be done.
To stop this once and for all.
And it's something I felt that it needed to be done...
so that he could suffer once and for all...
to see what he's done.
What everyone else has been able to do.
It's like...
to...
to get his own pain back.
I think it's so crazy...
how like...
it's so tragic and I suffer with them...
that I'm exhausted.
I have sympathy for them, I don't feel any sympathy for Zacharias.
I don't do that.
He's dead, I know that, but...
it was tragic that it started to end,
but that's how it happened.
What have you said to each other after the incident?
Well, we...
we've talked to each other and said that...
that we...
that we got rid of him.
We... or he...
that he's no longer a problem.
You've said that.
When did you say that?
I think a few days after we talked to each other...
but we just say that...
that we get to know.
That we keep a secret between me and Daniel.
And that's just it.
What's the reason you're telling us now?
It's mostly when I got...
I also got the message that...
I don't know, I was...
I think it was...
that Rasmus was hated and I thought...
how are you going to get rid of him when it's actually me who's behind this?
And then it was that...

I felt it instead.
It feels best that way.
To get it out of the way.
Like, people don't feel guilty and they don't feel right about me when...
I'm the one who's guilty, you know?
Now you've told us about this incident.
You've named one person by name.
You've sometimes talked about Anni.
Yes, my wife, she's dead.
And Rasmus Westman is dead.
They have nothing to do with this at all.
They...
I'm stuck with it and I...
I want them to get rid of me as soon as possible.
What I know is that it's me and Daniel who are guilty.
And that's the truth.
You say that it's you who's guilty.
Yes.
What do you mean by that?
We give the order to get rid of him today.
That's it.
Yes, he's dead.
What do you mean by that?
Sacrilege.
But...
Anni's involvement in this incident.
Yes.
What does she have to do with it?
What's her name?
Well...
She didn't like Sacrilege at all.
But she didn't have anything to do with the incident
that Daniel and I did.
With doing it.
Or with the others.
It was a decision that Daniel and I made.
Listen to Daniel Ström.
May, 2023.
This event has been going on for about two and a half months.
As you can see, we've been listening to each other
for different reasons.
Since then.
Since the last hearing with you,
one person has been arrested.

What do you say about that?

Nothing.

This person who was arrested last time
is Franz Westmann.

Your cousin.

What do you think about that?

Nothing special.

I heard about it on the TV show.

We've been listening to Franz.

He has told us what happened

on the ground floor

in Sacriage's apartment.
